KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO HUNDRED FORTY NINE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$249,900.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **SIDNEY KENT BROOKS AND WIFE, JANET I. BROOKS**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **TOD C. HANSON AND JEANINE M. HANSON** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:
