rights, if any.

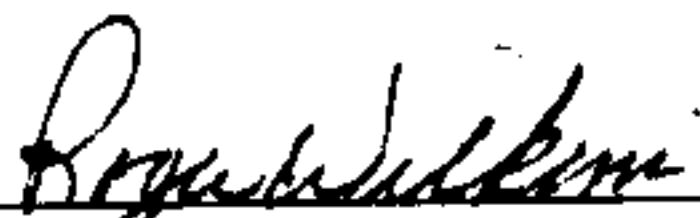
\$85,659.00 of the purchase price is being paid by the proceeds of a first mortgage

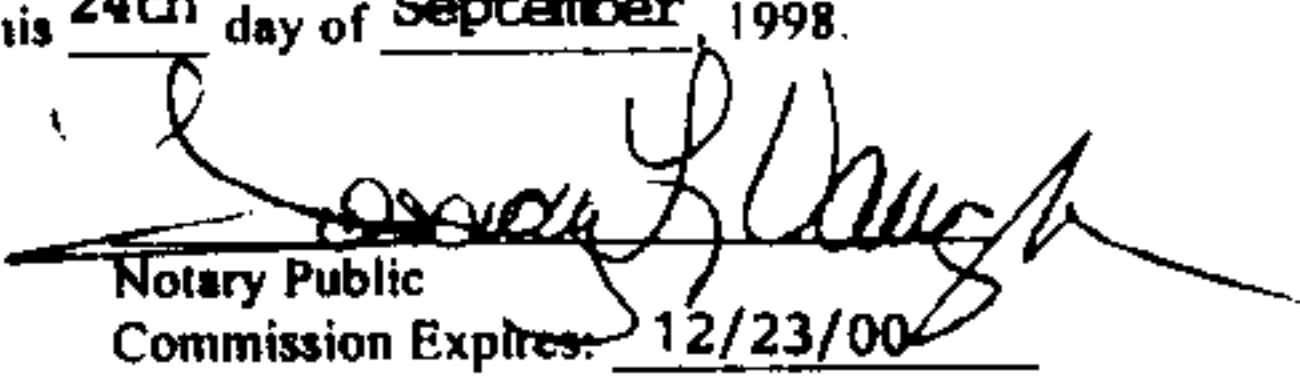
