FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT

STATE OF ALABAMA)

THIS FIRST AMENDMENT TO MORTGAGE AND SECURITY AGREEMENT ("First Amendment"), made and entered into effective as of the 27th day of October, 1998, by **GERALD DENNIS O'BRIEN**, a married man (the "Mortgagor"), and **COLONIAL BANK**, an Alabama banking corporation (the "Mortgagee").

WHEREAS, Mortgagor executed a certain Mortgage and Security Agreement dated as of the 8th day of November, 1995 (the "Mortgage"), and the Mortgage was recorded on November 9, 1995, at Instrument #1995-32444 in the Office of the Judge of Probate of Shelby County, Alabama (all capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Mortgage); and

WHEREAS, the original principal sum secured by the Mortgage was \$1,000,000.00 (the "Loan"), as evidenced by a promissory note (as amended from time to time, the "1995 Note"), and the principal balance currently outstanding under the 1995 Note is \$942,423.34; and

WHEREAS, the Mortgagee has agreed to loan additional funds in the principal amount of \$57,577.00 to Mortgagor and, concurrently herewith, Mortgagor is executing and delivering to Mortgagee a Promissory Note in the principal amount of \$57,577.00 (as amended from time to time, the "\$57,577.00 Note"), which \$57,577.00 Note is to be secured by, among other things, the Mortgage; and

WHEREAS, the Mortgagor and the Mortgagee have agreed to amend the Mortgage to provide security for the \$57,577.00 Note, all as more specifically hereinafter set forth.

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Mortgagor and Mortgagee hereby agree as follows:

1. The Mortgage is hereby amended in order to acknowledge the additional indebtedness owing by Mortgagor to Mortgagee pursuant to the \$57,577.00 Note, including, without limitation, principal of

\$57,577.00 plus interest thereon, and to provide that, in addition to any and all other indebtedness secured by the Mortgage, the Mortgage shall secure, and the term "indebtedness" as used in the Mortgage shall include, without limitation, all indebtedness owing by Mortgagor to Mortgagee pursuant to the \$57,577.00 Note.

2. Except as hereinabove expressly amended, the terms of the Mortgage are hereby ratified and affirmed.

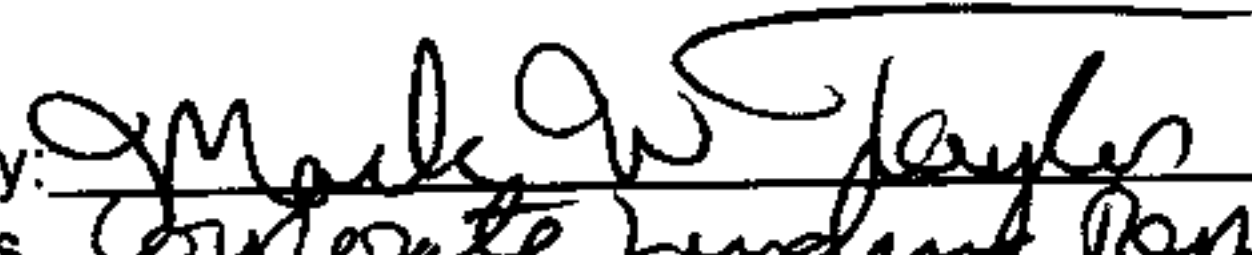
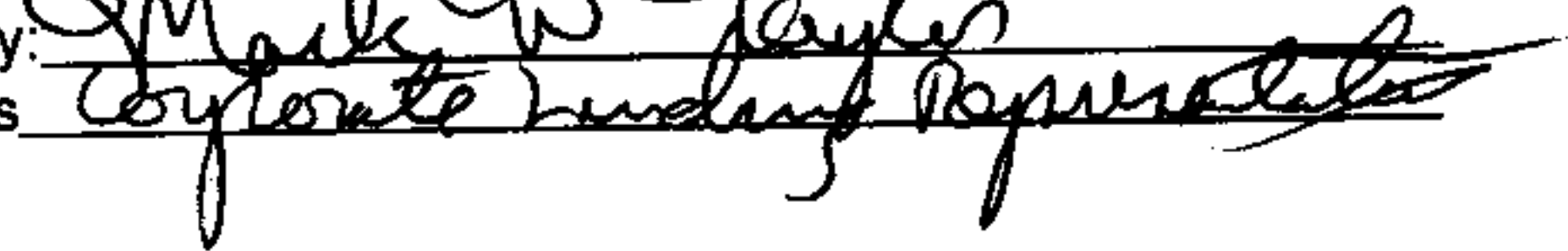
