KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRE SIXTY-TWO THOUSAND NINE HUNDRED DOLLARS AND NO/100's (\$262,900.00) to the undersigned grantor, GOODSSELL CONSTRUCTION CO., INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto JOHN C. HILL and ANDREA L. HILL (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in SHELBY County, Alabama:

Lot 1523, according to the Survey of Highland Lakes, 15th Sector, an Eddleman Community, as recorded in Map Book 23, Page 133, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
