KNOW ALL MEN BY THESE PRESENTS, That in consideration of TWO HUNDRED NINETY-EIGHT THOUSAND TWO HUNDRED AND NO/100 DOLLARS (\$298,200.00) to the undersigned grantor, KEN UNDERWOOD CLASSIC HOMES, INC., a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto STEVEN K. NELSON and ANGELA A. NELSON (herein referred to as GRANTEES) as joint tenants, with right of survivorship, the following described real estate, situated in Shelby County, Alabama:
