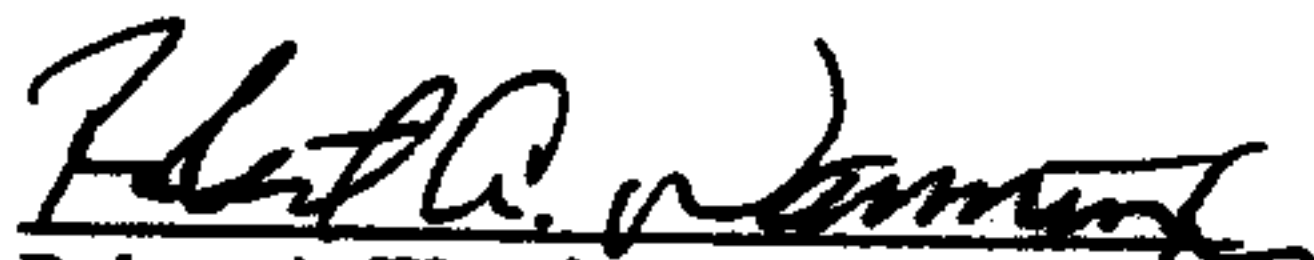

ANNEXATION ORDINANCE NO. X-98-09-01-083

PROPERTY OWNER(S): Annie B. Adams

PROPERTY: Parcel #08-7-26-0-001-011-000

Pursuant to the provisions of Section 11-42-21 of the Code of Alabama (1975),

Whereas, a written petition has been signed by Janice E. Clark as Power of Attorney for Annie B. Adams, owner of the above noted property included in the attached copy of the deed (Exhibit B, page 1) and further described in the attached copy of a tax notice for the said property (Exhibit B, page 2) requesting that said property be annexed to the Town of Chelsea, and

Whereas, said petition contains an accurate description of the property proposed to be annexed together with a map (Exhibit C) of the said property showing its relationship to the corporate limits of Chelsea; and

Whereas, said petition has been filed with the Chelsea town clerk; and

Whereas, said property is contiguous to the corporate limits of Chelsea, or is a part of a group of properties submitted at the same time for annexation which together is contiguous to the corporate limits of Chelsea; and

Whereas, said territory does not lie within the corporate limits of any other municipality; and

Whereas, even though said property is located in an area where the police jurisdiction of Chelsea and the police jurisdiction of Pelham overlap, the said property is less-than-equidistant from the respective corporate limits of Chelsea and Pelham (i.e. it is closer to the corporate limits of Chelsea than to the corporate limits of Pelham).

Therefore, be it ordained that the town council of the Town of Chelsea assents to the said annexation; and

Be it further ordained that the corporate limits of Chelsea be extended and rearranged so as to embrace and include said property, and said property shall become a part of the corporate area of the Town of Chelsea upon the date of publication of this ordinance as required by law.

PROPERTY DESCRIPTION

A description of the above-noted property, for which annexation into Chelsea is requested in this petition, is included in the attached copy of the deed (Exhibit B, page 1) which was recorded with the Shelby County judge of probate in Deed Book 107, page 77. It should be noted that the property for which annexation is hereby requested is less than that described in said deed due to the fact that parts of the described property were conveyed to others during the period since 1938. A precise description of the property for which annexation into Chelsea is hereby requested is presented on the attached copy of a tax notice (Exhibit B, page 2) from the Shelby County Tax Collector.

Further, the said property for which annexation into Chelsea is requested in this petition is shown in the shaded area on the attached map (Exhibit C) as Parcel # 11. Said map also shows the contiguous relationship of said property to the corporate limits of Chelsea (i.e. said property is contiguous to Parcel #4 which is contiguous to the corporate limits of the Town of Chelsea and which was annexed on the same date as said property).

The petition requesting that said property be annexed into the Town of Chelsea was signed by Janice E. Clark, Power of Attorney for her aunt, Annie B. Adams.

The said property for which annexation into Chelsea is requested in this petition does not lie within the corporate limits of any other municipality, but said property is located in an area where the police jurisdiction of Chelsea and the police jurisdiction of Pelham overlap. However, said property is less-than-equidistant from the respective corporate limits of Chelsea and Pelham (i.e. said property is closer to the corporate limits of Chelsea than to the corporate limits of Pelham) pursuant to Section 11-42-21, Code of Alabama (1975).

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Hundred Dollars and other valuable considerations to the undersigned grantor Laura Adams, a single woman in hand paid by A. C. Adams and Annie B. Adams, his wife, the receipt whereof is acknowledged I the said Laura Adams, a single woman do grant, bargain, sell and convey unto the said A. C. Adams and Annie B. Adams the following described real estate, to-wit: NE $\frac{1}{4}$ of NW $\frac{1}{4}$ Section 26, Township 19, Range 1 West containing forty acers, more or less-together with all improvements and also beginning at the NW corner of SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 26 TP. 19 R 1 W and going South to the right away of Florida Short Route Highway Thence East 1320 feet. Thence North to NE corner of said 40. Thence West 1320 to starting point containing 10 acres more or less.

TO HAVE AND TO HOLD, To the said A. C. Adams and Annie B. Adams heirs and assigns forever.

And I do, for myself and for my heirs, executors and administrators, covenant with the said A. C. Adams heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances; that I have a good right to sell and convey the same as aforesaid; that I will, and my heirs, executors and administrators, shall warrant and defend the same to the said A. C. Adams and Annie B. Adams, their heirs and assigns forever, against the lawful claims of all persons.
