IT IS AGREED by and between the Grantors and Grantee that Grantors grant to the City of Pelham a temporary easement fifty (50) feet in width, this dimension being twenty-five (25) feet to each side of the center line of the proposed sewer line and a thirty (30) foot wide permanent easement, this dimension being fifteen(15) feet on each side of the proposed sewer line, as constructed.


