KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THREE HUNDRED EIGHTY-SEVEN THOUSAND AND NO/100 DOLLARS (\$387,000.00)** to the undersigned grantor, **ROBERT S. GRANT CONSTRUCTION, INC., a corporation**, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of whereof is acknowledged, the said GRANTOR does by these presents grant, bargain, sell, and convey unto **JAMES R.
