- All rents, royalties, profits, issues and revenues of the Land and Improvements from time to time accruing. (:) whether under leases or tenancies now existing or hereafter created; and
- All judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings or the taking of the Land and improvements or any part thereof under the power of emment domain, or for any damage (whether caused by such taking or otherwise) to the Land and Improvements or any part thereof, or to (ii) any rights appurtament thereto, including any award for change of grade or streets. Lander is hereby authorized on behalf of and in the name of Borrower to execute and deliver valid acquittances for, and appeal from, any such judgments or awards. Lender may apply all such sums or any part thereof so received, after the payment of all its expenses, including costs and attorneys' fees, on any of the indebtedness secured hereby in such manner as it elects or, at its option, the entire amount or any part thereof so received may be released;
- All cash and non-cash proceeds and all products of any of the foregoing items or types of property described in (a), (b), (c) or (d) above, including, but not limited to, all insurance, contract and tort proceeds and claims, and including all inventory, accounts. (e) chartel paper, documents, instruments, equipment, fixtures, consumer goods and general intengibles acquired with cash proceeds of any of the foregoing items or types of property described in (a), (b), (c) or (d) above.

TO HAVE AND TO HOLD the Mortgaged Property and all parts thereof unto the Lender, its successors and assigns forever, subject, however, to the terms and conditions herein;

PROVIDED. HOWEVER, that these presents are upon the condition that, (i) if the Sorrower shall fully pay or cause to be fully paid to the Lander the principal and interest payable with respect of the Loan and the Note, and any extensions, renewals, modifications and refinencings of same, at the times and in the manner stipulated therein and herein, all without any deduction or credit for taxes or other similar charges paid by the Barrower, and shall pay all charges incurred herein by Lender on account of Barrower, including, but not limited to attorneys' less, and shall pey any and all Other indebtedness, and shall keep, parform and observe all and singular the covenents, conditions and agreements in this Mortgage, in the Note, in the other Loan Documents, and in the Other Indebtedness instruments expressed to be kept, performed, and observed by or on the part of the Borrower, all without fraud or delay, and (ii) the Lander shall have no further commitment or agreement to make advances, incur obligations or give value under the Loan, the Note, any other Loan Document or any Other Indabtedness instrument (including without limitation advances, obligations or value relating to future advances, open-end, revolving or other lines of credit), then this Mortgage, and all the properties, interest and rights hereby granted, bargained, sold and conveyed shall cease, terminate and be void, but shall otherwise remain in full force and effect.

AND the Borrower further represents, warrants, covenants and agrees with the Lender as follows:

## ARTICLE 1 **GENERAL**

- 1.01 Performance of Mortgege, Note and Loan Documents. The Borrower shall perform, observe and comply with all provisions hereof, of the Note, of the Losn Documents, and of the Other Indebtedness instruments, and shall duly and punctuelly pay to the Lender the sum of money expressed in the Note, with interest thereon, and all other sums required to be paid by the Borrower pursuant to the provisions of this Mortgage, of the Note, of the other Loen Documents, and of the Other Indebtedness Instruments, all without any deductions or credit for taxes or other similar charges paid by the Borrower.
- 1.02 Warranty of Title. Borrower hereby warrants that it is lawfully seized of an indefessible estate in fee simple in the land and rest property hereby mortgaged, or is lewfully seized of such other estate or interest as is described on Exhibit A hereto, and has good and absolute title to all existing personal property hereby granted as security, and has good right, full power and lawful authority to sell, convey, mortgage and grant a security interest in the same in the manner and form aforesaid; that the same is free and clear of all grants, reservations, security interests, liens, charges, and encumbrances whatspever, including, as to the personal property and fixtures, conditional sales contracts, chartel mortgages, security agreements, financing statements, and anything of a similar nature, and that Borrower shall and will warrant and forever defend the title thereto and the quiet use and enjoyment thereof unto the Lender, its successors and sesigns, against the lawful claims of all persons whomspever.
- 1.03 Future Advances, Revolving and Open-End Loans, and Other Debts. It is expressly understood that this Mortgage is intended to and does secure not only the Loan, but also future advances and any and all Other Indebtedness, obligations and liabilities, direct or contingent, of the Borrower to the Lender, whether now existing or hereafter ansing, and any end all extensions, renewals, modifications and refinancings of same, or any part thereof, existing at any time before actual cancellation of this instrument on the probate records of the county or counties where the Mortgaged Property is located, and whether the same be evidenced by note, open account, assignment, endorsement, guaranty, pledge or otherwise. The Loan and the Other Indebtedness may, if provided in the applicable loan instruments, provide for revolving or open end loans and advances, all of which shall be secured by this Mortgage.
- 1.04 Monthly Tax Deposit. It required by Lender, Borrower shall pay on the first day of each month one-twelfth (3/32) of the yearly texes on the Mortgaged Property, as estimated by Lender, in addition to each regular installment of principal and interest. Such sums shall not draw interest and shall not be, not be deemed to be, trust funds, but may be commingled with the general funds of Lender. Borrower agrees to pay Lender the emount of any deficiency necessary to enable Lender to pay such taxes when due. Such sums may be applied by the Lender to the reduction of the indebtedness secured hereby in any manner selected by Lander if an Event of Datault shall occur under this Mortgage or under the Note, any of the other Loan Documents, or any of the Other Indebtedness Instruments, but, unless otherwise agreed by the Lender in writing. no application of tax deposits to the Note, to Other Indebtedness, or to other obligations secured hereby, shall dalay, reduce, siter or otherwise affect any regularly scheduled payment with respect to the Loan, the Other indebtedness, or any such other obligations.

## 1.05 Other Taxes, Utilities and Liens.

- The Borrower shell pay promptly, when and as due, and, if requested, will exhibit promptly to the Lender receipts for the payment of all taxes, assessments, water rates, utility charges, dues, charges, lines, penalties, costs and other expenses incurred, and impositions of every nature whatsoever imposed, levied or essessed or to be imposed, levied or assessed upon or against the Mongaged Property or any part theteof or upon the revenues, rents, results and profits of the Mortgaged Property or arising in respect of the occupancy, use or possession thereof, or upon the interest of the Lender in the Mortgaged Property (other than any of the same for which provision has been made in Paragraph 1.04 of this Article II, or any charge which, if unpaid, would become a ken or charge upon the Mortgaged Property.
- The Borrower promptly shall pay and shall not suffer any mechanic's, laborer's, statutory or other lien to be created or to remain
- in the event of the passage of any state, federal, municipal or other governmental law, order, rule or regulation, subsequent to the outstanding upon env of the Mortgeged Property. date hereof, in any menner changing or modifying the laws now in force governing the taxation of mortgages or debts secured by mortgages or the manner or collecting taxes, then Borrower immediately shall pay any increased taxes if allowed by law, and if Borrower laws to pay such additional taxes, or if Borrower is prohibited from paying such taxes, or it Lander in any way is adversely affected by such law, order, rule or regulation, then in any of such events, all indebtedness secured by this Mortgage and all interest accrued thereon shall without notice become due and payable forthwith at the option of the Lendar.

### 1.06 insurance.

The Sorrower shall produce for, deliver to, and maintain for the benefit of the Lander during the term of this Mortgage insurance policies in such amounts as the Lender shall require, insuring the Mortgaged Property against fire, extended coverage, was damage of evaluables. and such other insurable hazards, casualties and contingencies as the Lender may require. The form of such policies and the companies issuing them shall be acceptable to the Lender, and, unless otherwise agreed by the Lender in writing, shall provide for coverage without coinsurance or deductibles. All policies shall contain a New York standard, non-contributory mortgage endorsement making losses payable to the Landard as mortgages. At least fifteen (15) days prior to the expiration date of all such policies, renewals thereof satisfactory to the Lender shall be delivered to the Lender. The Borrower shall deliver to the Lender receipts evidencing the payment of all such insurance policies and renewals. In the event of the foreclosure of this Mortgage or any transfer of title to the Mortgaged Property in partial or full extinguishment of the indebtedness secured hereby, all right, title and interest of the Borrower, or its assigns, in and to all insurance policies then in force shall pass to the purchaser or ۱. grantee.

St. Market School Security

- the Mortgaged Property, and to collect and receive the proceeds from any such policy or policies. Each insurance company hereby is authorized and directed to make payment for all such losses directly to the Lander instead of to the Borrower and Lender jointly. After deducting from said insurance proceeds any expenses incurred by Lender in the collection or handling of said funds, the Lender may apply the net proceeds, at its option, either toward repairing or restoring the improvements on the Mortgaged Property, or as a credit on any portion of the Borrower's indebtedness selected by Lender, whether then metured or to meture in the future, or at the option of the Lender, such sums either wholly or in part may be used to repair such improvements, or to build new improvements in their place or for any other purpose and in a manner satisfactory to the Lender, all without affecting the lien of this Mortgage for the full amount secured hereby before such payment took place. Lender shall not be liable to Borrower or otherwise responsible for any failure to collect any insurance proceeds due under the terms of any policy regardless of the cause of such failure.
- (c) If required by the Lender, the Borrower shall pay on the first day of each month, in addition to any regular installment of principal and interest and other charges with respect to indebtedness secured hereby, and the monthly tax deposit provided for in Paragraph 1.04 hereof, one-twelfth (1/12) of the yearly premiums for insurance maintained pursuant to the provisions of this Paragraph 1.06. Such amount shall be used by Lender to pay such insurance premiums when due. Such added payments shall not be, nor be deemed to be, trust funds, but may be commingled with the general funds of the Lender, and no interest shall be payable in respect thereof. Upon demand of the Lender, the Borrower agrees to deliver to the Lender such additional moneys as are necessary to make up any deficiencies in the amounts deposited by Borrower with Lender pursuant to this Paragraph 1.08 to enable the Lender to pay such insurance premiums when due. In the event of an Event of Default heraunder or of a default by Borrower under the Note, any other Loan Documents, or any Other Indebtedness Instruments, the Lender may apply such sums to the reduction of the indebtedness secured hereby in any manner selected by Lender, but, unless otherwise agreed by the Lender in writing, no application of insurance proceeds to the Loan, to Other Indebtedness, or to other obligations secured hereby, shall delay, reduce, siter or otherwise affect any regularly scheduled payment with respect to the Loan, the Other Indebtedness, or any such other obligations
- 1.07 Condemnation. If all or any part of the Mortgaged Property shall be damaged or taken through condemnation (which term when used in this Mortgage shall include any damage or taking by any governmental or private authority, and any transfer by private sale in bot thereoff; either temporarily or permanently, the entire indebtedness secured hereby shall at the option of the Lender become immediately due and payable. The Lender shall be entitled to all compensation, awards, and other payments or relief for any condemnation and is hereby authorized, at its option, to commence, appear in and prosecute, in its own or the Borrower's name, any action or proceeding relating to any condemnation, and to sattle or compromise any claim in connection therewith. All such compensation, awards, demages, claims, rights of action and proceeds and the right thereto are hereby assigned by the Borrower to the Lender, which, after deducting therefrom all its expenses, including attorneys' tees, may release any moneys so received by it without affecting the list of this Mortgage or may apply the same in such manner as the Lender shall determine to the reduction of the indebtedness secured hereby, and any belance of such moneys then remaining shall be paid to the Borrower agrees to execute such further assignments of any compensations, awards, damages, claims, rights of action and proceeds as the Lender may require. The Borrower shall promptly notify the Lender in the event of the institution of any condemnation or eminent domain proceeding or in the event of any threat thereof. The Lender shall be under no obligation to the Borrower, its own legal counsel in connection with any such proceedings or threatened proceedings, Lender shall be under no obligation to the Borrower or to any other person to determine the sufficiency or legality of any condemnation award and may accept any such award without question or further inquiry.

#### 1.08 Care of the Property.

- (a) The Borrower will preserve end maintain the Mortgaged Property in good condition and repair, and shall not commit or suffer any waste end will not do or suffer to be done enything which will increase the risk of fire or other hexard to the Mortgaged Property or any part thereof.
- (b) Except as otherwise provided hersin, no buildings, fixtures, personal property, or other part of the Mortgaged Property shall be removed, demdished or substantially altered without the prior written consent of the Lender. The Borrower may sell or otherwise dispose of, free from the lien of this Mortgage, furniture, furnishings, equipment, tools, appliances, mechinery or appurtenances, subject to the lien hereof which may become worn out, undesirable, obsolets, disused or unnecessary for use in the operation of the Mortgaged Property, not exceeding in value at the time of disposition thereof five Thousand Dollars (\$5,000.00) for any single transaction, or a total of Twenty Thousand Dollars (\$20,000.00) in any one year, upon replacing the same with, or substituting for the same, free and clear of all liens and security interests except those created by the Lean Documents or Other Indebtedness Instruments, other furniture, furnishings, equipment, tools, appliances, mechinery or appurtenances not necessarily of the same character, but of at least equal value and of equal or greater utility in the operation of the Mortgaged Property, and costing not less then the amount realized from the property sold or otherwise disposed of. Such substitute furniture, furnishings, equipment, tools, appliances, mechinery and appurtenances shall forthwith become, without further action, subject to the provisions of this Mortgage.
- (c) If the Mortgaged Property or any part thereof is damaged by fire or any other cause, the Borrower shall give immediate written notice of the same to the Lander.
- (d) The Lander is hereby authorized to enter upon and inspect the Morrgaged Property, and to inspect the Sorrower's or Borrower's agent's records with respect to the ownership, use, management and operation of the Morrgaged Property, at any time during normal business hours.
- (a) If all or any part of the Mortgaged Property shall be damaged by fire or other casualty, the Borrower shall promptly restore the Mortgaged Property to the equivalent of its original condition, regardless of whether or not there shall be any insurance proceeds therefor; provided, however, that if there are insurance proceeds, the Borrower shall not be required to restore the Martgaged Property as aforessid unless the Lender shall apply any net proceeds from the casualty in question and held by Lender, as allowed under Paragraph 1.06, toward restoring the damaged improvements. If a part of the Mortgaged Property shall be physically damaged through condamnation, the Borrower promptly shall restore, repair or after the remaining property in a manner satisfactory to the Lender; provided, however, that if there are condemnation proceeds or awards, the Borrower shall not be required to restore the Mortgaged Property as aforesaid unless the Lander shall apply any net proceeds or awards from the condemnation and held by Lander, as provided in Paragraph 1.07, toward restoring the damaged improvements.

### 1.09 Further Assurances; After-Acquired Property.

- (a) At any time, and from time to time, upon request by the Lender, the Borrower, at Borrower's expense, will make, execute and deliver or cause to be made, executed and delivered to the Lender and, where appropriate, to cause to be received and/or filled and from time to time thereafter to be re-recorded and/or reflied at such time and in such offices and places as shall be deemed desirable by the Lender, any and all such other and further mortgages, instruments of further assurance, certificates and other documents as may, in the opinion of the Lender, be necessary or desirable in order to effectuate, complete, or perfect, or to continue and preserve the obligation of the Borrower under the Note and this Mortgage, and the priority of this Mortgage as a first and prior lien upon all of the Mortgaged Property, whether now owned or hereafter acquired by the Borrower. Upon any failure by the Borrower so to do, the Lender may make, execute, and record any and all such mortgages, instruments, certificates, and documents for and in the name of the Borrower and the Borrower hereby irrevocably appoints the Lender the agent and attorney-in-fact of the Borrower so to do. The lien and rights hereunder automatically will attach, without further act, to all after-acquired property texcept consumer goods, other than accessions, not acquired within ten (10) days after the Lender has given value under the Note) attached to and/or used in the operation of the Mortgaged Property or any part thereof.
- (b) Without limitation to the generality of the other provisions of this Mortgage, including subparagraph (a) of this Paragraph 1.0%, it hereby expressly is coveramed, agreed and acknowledged that the lien and rights hereunder automatically will attach to any further, greater, additional, or different estate, rights, titles or interest in or to any of the Mortgage Property at any time acquired by the Sorrower by whatsoever means, including that in the event that the Borrower is the owner of an estate or interest in the Mortgaged Property or any part thereof (such as tor example, as the lesses or tenant) other than as the fee simple owner thereof, and prior to the estistaction of record of this Mortgaged Borrower obtains or otherwise acquires such fee simple or other estate, then such further, greater, additional, or different estate in the Mortgaged Property, or a part thereof, shall automatically, and without any further action or filing or recording on the part of the Borrower or the Lander or any other person or entity, be and become subject to this Mortgage and the lien hereof. In consideration of Lender's making the Loan as aforesaid, and to secure the Loan, the Other Indebtedness and obligations set forth above, Borrower hereby grants, bargains, sails and conveys to Lender, on the same terms as set forth in this Mortgage and intended to be a part hereof, all such after-acquired property and extetes.
- 1.10 Additional Security. The Lender also shall have and is hereby granted a security interest in all momes, securities and other property of the Borrower, now or hereafter assigned, held, received, or coming into the possession, control, or custody of the Lender by or for the account of the Borrower (including indebtedness due from the Lender to the Borrower, and any and all claims of Borrower against Lender, at any time existing) whether expressly as colleteral security, custody, pledge, transmission, collection or for any other purpose, and also upon any and all deposit balances, including any dividends declared, or interest accruing thereon, and proceeds thereof. On an Event of Default, the Lender may, in addition to any other rights provided by this Mortgage or any other of the Loan Documents, but shall not be obligated to, apply to the payment of the Loan or Other Indebtedness secured hereby, and in such manner as the Lender may determine, any such morries, securities or other property held or controlled by the Lender. No such application of funds shall, unless otherwise expressly agreed by the Lender in writing, reduce, after, delay or otherwise affect any regularly scheduled payment with respect to the Loan or such Other Indebtedness or obligations.

- 1.11 Leases Affecting Mortgaged Property. The Serrower shall comply with and observe its obligations as landlord or tanent under sit leases effecting the Mortgaged Property or any part thereof. If requested by Lender, Borrower shell lurrish Lender with executed Socies of all isspes now or hereafter created on the Montgaged Property; and all leases now or hereafter entered into will be in form and substance subject to the approval of Lender. Somewer shall not eccept payment of rent more than one (1) month in advance without the express written consent of Lander. If requested by the Lender, the Borrower shall execute and deliver to Lender, as additional security, such other documents as may be requested by Landar to evidence further the assignment to Landar hareunder, and to assign any and all such leases whether now existing or harsefter created, including, without limitation, all rents, royalties, issues and profits of the Mortgeged Property from time to time econsing. The Borrower shall not consel, surrender or modify any lease affecting the Montgaged Property or any part thereof without the written consent of the Longibr.
- 1.12 Expenses. The Borrower shall pay or reimburse the Lender for all reasonable artorneys' fees, costs and expenses incurred by the Lander in connection with the collection of the indebtedness secured hereby or the enforcement of any tights or remedies provided for in this Mortgage, in any of the other Loan Documents or the Other Indebtedness Instruments, or as may otherwise be provided by law, or incurred by Lender in any proceeding invehing the setate of a decedem or an insolvent, or in any action, proceeding or dispute of any kind in which the Lender is made a party, or appears as party plaintiff or defendant, affecting this Mortgage, the Note, any of the Loan Documents, any of the Other indebtedness instruments, Borrower or the Mortgaged Property, including but not limited to the foreclosure of this Mortgage, any condemnation action involving the Mortgaged Property, any environmental condition of or effecting the Mortgaged Property, or any action to protect the security hereof; and any such amounts paid or incurred by the Lander shall be added to the indebtedness secured hereby and shall be further secured by this Mortgage.
- 1.13 Performance by Lender of Defaults by Borrower. If the Borrower shall default in the payment of any tax, lien, assessment of charge levied or assessed against the Mortgaged Property, or otherwise described in Paragraphs 1.04 and 1.05 hereof; in the payment of any utility charge, whether public or private; in the payment of insurance premiums; in the procurement of insurance coverage end the delivery of the insurance policies required hereunder; or in the performance or observance of any other covenant, condition or term of this Mortgage, of the Note, of any of the other Loan Documents, or of any of the Other Indebtedness instruments, then the Lender, at its option, may perform or observe the same; and all payments made for costs or expenses incurred by the Lender in connection therewith shall be secured hereby and shall be, without demand, immediately repaid by the Borrower to the Lender with interest thereon calculated in the manner set forth in the Note, and at the default interest rate specified in the Note, or, if no defeut interest rate is specified, then at the rate set forth in the Note plus two percentage points (2%). The Lender shall be the sole judge of the legality, validity and priority of any such tax, lien, assessment, charge, claim and premium, of the necessity for any such actions and of the emount necessary to be paid in estietaction thereof. If an Event of Default shall have occurred and be continuing, the Lender may enhance with or without entry or taking possession as hereinsbove provided or otherwise, proceed by suit or suits at law or in equity or any other appropriate proceeding or ramedy (a) to enforce payment of the Loan; (b) to foreclose this Mortgage; (c) to enforce or exercise any right under any Other indebtedness instrument; and (d) to pursue enviether remedy available to Lender, all as the Lender may elect.
- Rights of a Secured Party.
