KNOW ALL MEN BY THESE PRESENTS, That in consideration of **THREE HUNDRED EIGHT THOUSAND DOLLARS AND NO/100's (\$308,000.00)** to the undersigned grantor, **KEN UNDERWOOD CLASSIC HOMES, INC.**, a corporation, (herein referred to as **GRANTOR**), in hand paid by the **GRANTEES** herein, the receipt of whereof is acknowledged, the said **GRANTOR** does by these presents grant, bargain, sell, and convey unto **RICKY L. EDWARDS and SUZANNE M. EDWARDS** (herein referred to as **GRANTEES**) as joint tenants, with right of survivorship, the following described real estate, situated in **SHELBY County, Alabama**:
