Builders, L.L.C.	_, the Borrower(s), and First Federal Savings Bank (formerly First
Factoral Sevings and Loan Association of Bessemer), the Lender	r, as follows:

- 1. Expenditures by Lender, indebtedness to Lender. It is expressly understood and agreed that the Mortgage and Note will secure any future indebtedness of the Borrower to Lender regardless of the amount and source. The Lender may do and pay for whatever is necessary to protect the value of the Property and Lender's rights in the Property, including, but not limited to paying: any sum secured by a lien which has priority over this.
