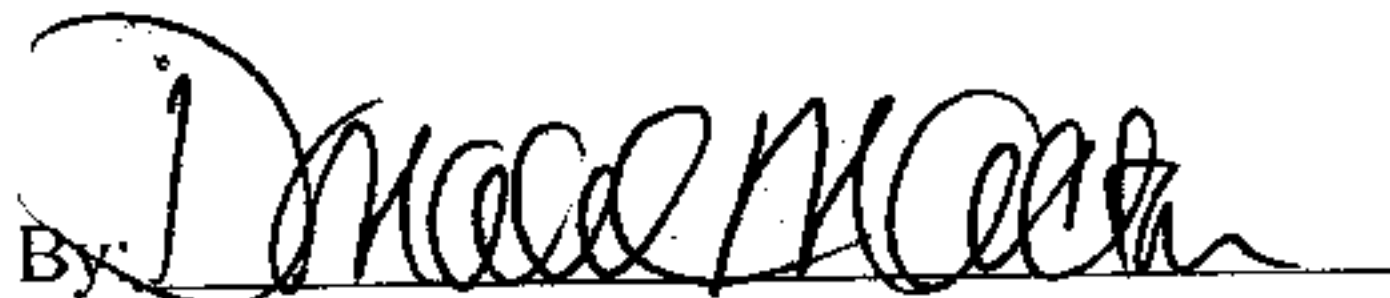

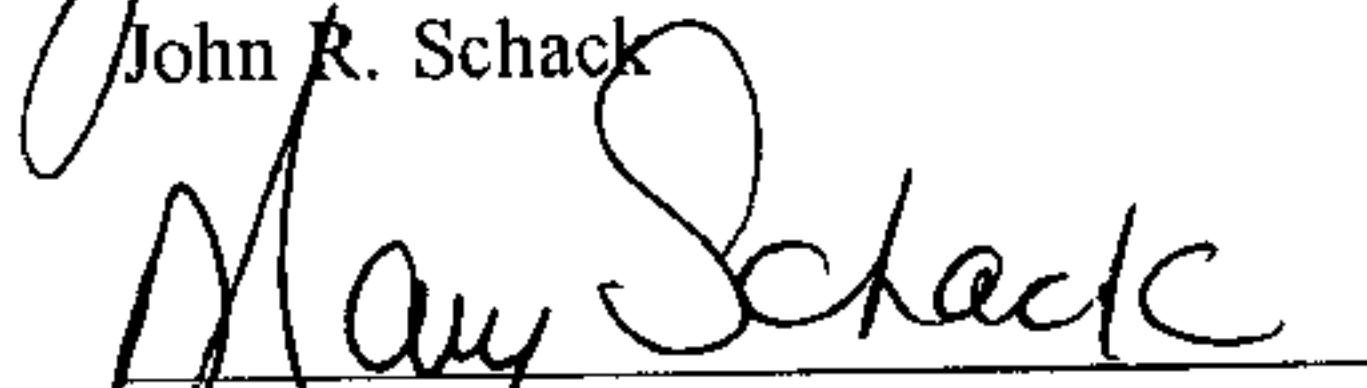
That in consideration of ten dollars and other good and valuable consideration paid by Shelby County, Alabama, ("Shelby County"), a county of the State of Alabama, to John R.
