THIS MORTGAGE IS DATED JULY 27, 1999, between ROBERT EDWARD JORDAN and DEBBIE JAN JORDAN, man & wife, whose address is 237 CAHABA QAKS TRL, INDIAN SPRINGS, AL 35124-3334 (referred to below as "Grantor"); and Regions Bank, whose address is 2964 Pelham Parkway, Pelham, AL 35124 (referred to below as "Lender").

GRANT OF MORTGAGE. DEFINITIONS: The following words shall have the following meanings when used in this Mortgage.
