## RELEASE AND SATISFACTION OF MORTGAGE

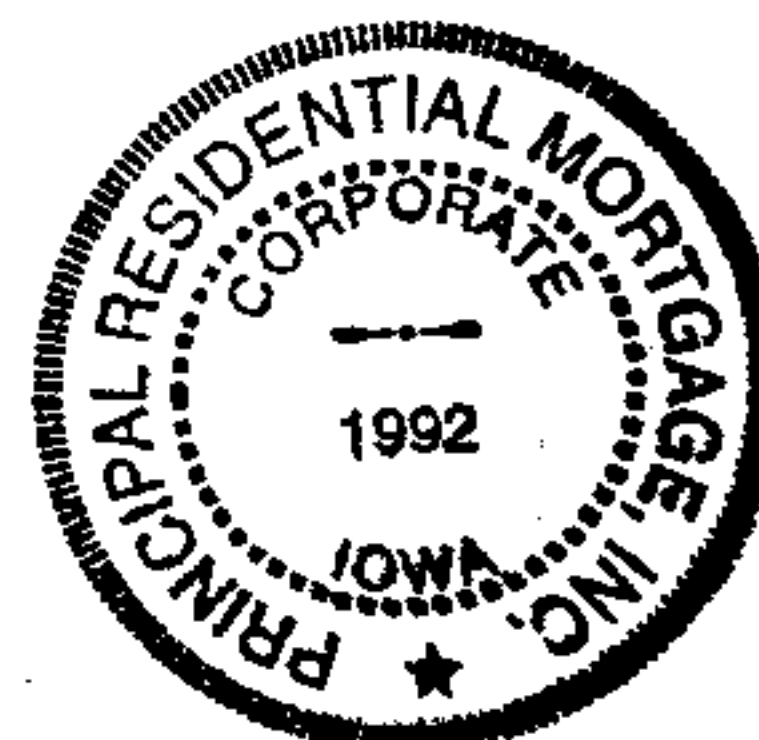
