Together with all the rights, privileges, tenements, appurtenences and fixtures appartaming to the Real Estate, all of which shall be deemed Real Estate and shall be conveyed by this mortgage.

TO HAVE AND TO HOLD the Real Estate unto the Mortgages, its successors and assigns forever. The Mortgagor covenants with the Mortgages that the Mortgagor is lewfully souted in fee simple of the Real Estate and has a good right to sell and convey the Real Estate as aforesaid; that the Real Estate is free of all encumbrances, except the lien of current ad valorem taxes, and the Mortgagor will warrant and forever defend the title to the Real Estate unto the Mortgagoe, against the tawful claims of all persons, except as otherwise herein provided.

For the purpose of further securing the payment of the debt, the Mortgagor agrees to: (1) pay promptly when due all taxes, assessments, and other tens taking priority over this mortgage (hereinatter jointly called "Liens"), when imposed legally upon the Real Estate and if default is made in the payment of the Liens, or any part thereof the Mortgagee, at its option, may pay the same; (2) keep the Fieal Estate continuously insured, in such menner and in such companies as may be satisfactory to the Mor (gages, against loss by fire, vandalism, malicious mischief and other peris usually covered by a fire insurance policy with standard extended coverage endorsements. with loss, if any, payable to the Mortgagee, as its interest may appear; such insurance to be in an amount sufficient to cover the clebt. The original insurance policy, and all replacements therefor, shall be delivered to and held by the Mongages until the debt is paid in fulf. The original insurance policy and all replacements therefor must provide that they may not be cancelled without the insurer giving at least fifteen days prior written notice of such cancellation to the Mortgages. The Mortgagor hereby assigns and pledges to the Mortgages, as further security for the payment of the debt, each and every policy of hezard insurance now or hereafter in effect which insures said improvements, or any part thereof, together with all the right, title and interest of the Mortgagor in and to each and every such policy, including but not limited to all of the Mortgagor's right, title and interest in and to any premiums peid on such hazard insurance, including all rights to return premiums. If the Mortgager fails to keep the Real Estate insured as specified above then, at the election of the Mortgages and without notice to any person, the Mortgages may declare the entire distriction and payable. and this mortgage subject to foreclosure, and this mortgage may be to eclosed as heremater provided, and, regardless of whether the Mortgagee declares the entire debt due and payable, the mortgages may, but shall not be obligated to, insure the Real Estate for its full insurable value (or for such lesser amount as the Mortgages may wish) against such risks of lose, for its own benefit the proceeds from such insurance (less cost of collecting same), if collected, to be credited against the diebt, or at the election of the Mortgagea, such proceeds may be used in repairing or reconstructing the improvements located on the Real Estate. The Mortgagor agrees to pay promptly when due the principal and interest of the debt and keep and perform every other covenant and agreement of the Promissory Note ascured hereby.

As further security for the payment of the debt, the Mortgagor hereby assigns and pladges to the Mortgagoe, the following described property rights, claims, fents, profits, assues and revenues.

- 1. All rents, profits, issues, and revenues of the Real Estate from time to time accruing, whether under lesses or tenancies now existing or hereafter breated reserving to the Mongagor, so long as the Mongagor is not in default hereunder, the right to receive and retain such rents, profits, issues and revenues.
- 2. All judgments, awards of damages and settlements hereafter made resulting from condemnation proceedings or the talang of the Real Estate, or any part thereof, under the power of emment domain, or for any damage (whether caused by such talang or otherwise) to the Real Estate, or any part thereof, or to any rights appurtenent thereto, including any award for change of grade of streets, and all payments made for the voluntary sale of the Real Estate, or any part thereof, in lieu of the exercise of the power of emment domain, shall be paid to the Mortgages. The Mortgages is hereby authorized on behalf of and in the name of the Mortgagor to execute and deliver valid acquittances for, appeal from, any such judgments or awards. The Mortgages may apply all such aums received, or any part thereof, after the payment of all the Mortgages's expenses incurred in connection with any proceeding or transaction described in this subparagraph. Including court costs and attorney's fees, on the disbt in such menner as the Mortgages elects, or, at the Mortgages's option, the entire amount or any part thereof so received may be released or may be used to rebuild, repair or restore any or all of the improvements located on the Real Estate.
