

**ARTICLES OF ORGANIZATION  
OF  
LET'S MOVE IT, LLC**

**TO THE HONORABLE JUDGE OF PROBATE  
OF SHELBY COUNTY ALABAMA:**

The undersigned, for the purpose of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act as codified in Alabama Code § 10-12-1, et seq. (the "Act") hereby certifies as follows:

1. NAME. The name of the Company is:

"LET'S MOVE IT, LLC"

2. OPERATING AGREEMENT. The affairs of the Company, the conduct of its business and the relations of its members, are regulated and established under the Company's Operating Agreement for Let's Move It, LLC as the same may be amended from time to time in accordance with its terms (the "Operating Agreement").

3. PURPOSES and DURATION. The Company has been organized for the purpose of moving, warehousing, loading and unloading and storage of property. The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company. The period of duration of the Company shall be perpetual.

6. ADDITIONAL AND SUBSTITUTE MEMBERS. Any new or substitute members shall be admitted to the Company only in accordance with the terms set forth in the Operating Agreement.

7. CESSATION OF MEMBERSHIP OF ALL MEMBERS. The cessation of membership of all members will result in the dissolution of the Company unless the holders of all the financial rights in the Company agree in writing, within ninety (90) days after the cessation of membership of the last member, to continue the legal existence and business of the Company and to appoint one or more new members.
