

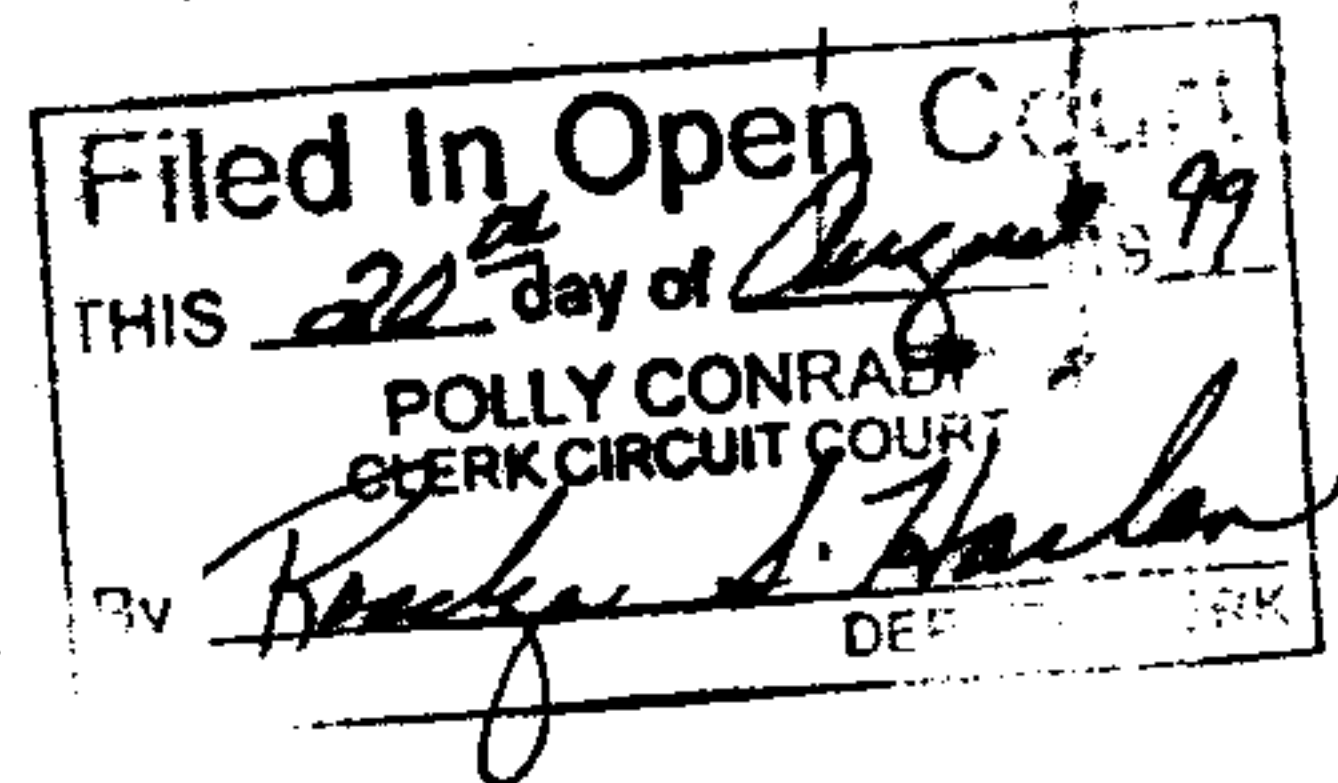

- (6) Opposition of Defendant, Tim McCoy, to Plaintiff's Motion for Summary Judgment.


