MORTGAGE THIS IS A FUTURE ADVANCE MORTGAGE

THIS MORTGAGE IS DATED FEBRUARY 7, 2000, between BENNETT KEITH STARNES and APRIL D. STARNES. WITH TITLE VESTED AS KEITH STARMES, A.K.A. BENNETT KEITH STARNES, AND WIFE, whose address is 45 N RIVER RD, SHELBY, AL 35143 (referred to below as "Grantor"); and AmSouth Bank, whose address is 520 Montgomery Highway, Vestavia Hills, AL 35216 (referred to below as "Lender").

GRANT OF MORTGAGE. Improvements. The word "Improvements" means and includes without limitation all existing and future improvements, buildings, structures, mobile homes affixed on the Real Property, facilities, additions, replacements and other construction on the Real Property.

Indebtedness. The word "Indebtedness" means all principal and interest payable under the Credit Agreement and any amounts expended or advanced by Lander to discharge obligations of Grantor or expenses incurred by Lander to enforce obligations of Grantor under this Mortgage together with interest on such amounts as provided in this Mortgage and any and all other present or future, direct or contingent liabilities or Indebtedness of eny person who signs the Credit Agreement to the Lender of any nature whatsoever, whether classified as secured or unsecured, except that the word "indebtedness" shall not include any debt subject to the disclosure requirements of the Federal Truth-in-Lending Act if, at the time such debt is incurred, any legally required disclosure of the lien afforded hereby with respect to such debt shall not have been made. The provisions of this section of the Mortgage, including the obligation to indemnify, shell survive the payment of the indebtedness and the satisfaction and reconveyance of the lien of this Mortgage and shall not be affected by Lender's acquisition of any interest in the Property. whether by foreclosure or otherwise.

Nulsance, Waste. Grantor shall not cause, conduct or permit any nulsance nor commit, permit, or suffer any stripping of or waste on or to the Property or any portion of the Property. Without limiting the generality of the foregoing, Grantor will not remove, or grant, to any other party the right to remove, any timber, minerals (including oil and gas), soil, gravel or rock products without the prior written consent of Lander.

Removal of improvements. Grantor shell not demolish or remove any improvements from the Resi Property without the prior written consent of Lander. Right To Contest. If a lien srises or is filed as a result of nonpayment, obligation to pay, so long as Lender's interest in the Property is not jeopardized.
