KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **One Hundred Thirty Five Thousand Eight Hundred Seventy Five and 00/100 Dollars (\$135,875.00)** to the undersigned GRANTOR in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, **Doyal Construction Co., Inc.**, an Alabama Corporation (hereinafter referred to as GRANTOR), does hereby grant, bargain, sell and convey unto **Rudolph B. Kamman and Sonya S. Kamman, husband and wife** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of **Shelby** and State of **Alabama**, to-wit:
