**STATE OF ALABAMA )**

**SHELBY COUNTY ) KNOW ALL MEN BY THESE PRESENTS,**

That in consideration of the sum of **One Hundred Nineteen Thousand Nine Hundred and 00/100 Dollars (\$119,900.00)** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Larry J. Bailey and Connie S. Bailey, Husband and Wife** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Jason M Greer and Tanya W. Greer, as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **SHELBY COUNTY, ALABAMA:**

**Lot 42, according to the Survey of Hunter's Glen, as recorded in Map Book 6, Page 49, in the Probate Office of Shelby County, Alabama**



Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.
