(h) to set-off Mortgagor's Obligations against any amounts owed Mortgagor by Lender including, but not limited to monies, instruments, and

deposit accounts maintained with Lender or any currently existing or future affiliate of Lender; and (i) to exercise all other rights available to Lender under any other written agreement or applicable law.

If Mortgagor is in default under this Mortgage, this Mortgage shall be subject to foreclosure at Lender's option. 23. APPLICATION OF PAYMENTS. 26. PARTIALRELEASE.
