FINAL ORDER OF JUDGMENT

RULE 54B AGAINST W.D. BULLOCK, INDIVIDUALLY

This matter was submitted to Court on the Plaintiff's Motion for Summary Judgment on March 6, 2000. The Defendant did not appear or file any response to the Motion. Upon consideration of the Motion of the Plaintiff, the Court finds that relief is to be granted in favor of the Plaintiff against the Defendant, W. D. Bullock, individually. It is therefore ORDERED as follows:

1. That the Plaintiff recover a Judgment against the individual Defendant, W. D. Bullock in the amount of Thirty Two Thousand Five Hundred Thirty-Three Dollars (\$32,533.00), including interest at the rate of 6% from September 1999, to February 2000, in the amount of Nine Hundred Seventy Five and 99/100ths Dollars (\$975.99). The total Judgment against the Defendant is Thirty Three Thousand Five Hundred Twenty-Nine and 59/100ths Dollars (\$33,529.59).
2. Tax cost against the Defendant for which that execution issue.
3. Upon an express direction for entry of Judgment under Rule 54B
