Know All Men by These Presents: That in consideration of ONE HUNDRED THIRTEEN THOUSAND THREE HUNDRED SEVENTY FIVE and 00/100 (\$113,375.00) DOLLARS to the undersigned grantor, JOE ROSE HOMEBUILDERS, INC. in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR, does by these presents, grant, bargain, sell and convey unto WILLIAM J. AGERTON and LESLIE Y. AGERTON, HUSBAND AND WIFE, (herein referred to as GRANTEES, as joint tenants, with right of survivorship, whether one or more) the following described real estate, situated in SHELBY County, Alabama, to-wit:
