**CORPORATION WARRANTY DEED  
(With Survivorship)**

**THE STATE OF ALABAMA )  
COUNTY OF SHELBY )**

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Hundred One Thousand (\$101,000.00) Dollars, in hand paid to Shelby Springs Stock Farm, Inc., a corporation (hereinafter referred to as "GRANTORS"), by Jacqueline P. Hancock and D. Matson Brewer (hereinafter referred to as "GRANTEE"), the receipt of which is hereby acknowledged, the said GRANTORS do by these presents, grant, bargain, sell and convey unto GRANTEE the following described real estate, located and situated in Shelby County, Alabama, to wit:

Lot 14, according to Shelby Spring Farms, Lakeland Sector 2, as recorded in Map Book 24, page 144 A, B and C, in the Office of the Judge of Probate of Shelby County, Alabama.

10. 30 foot ingress/egress and drainage easement, on the Southeast corner, as shown on recorded map.




