THIS MORTGAGE IS DATED JUNE 5, 2000, between HPH Properties, Inc., a corporation, whose address is 2224 Cahaba Valley Drive, Suite 8-3, Birmingham, AL 35242 (referred to below as "Grantor"); and Regions Bank, whose address is P. O. Box 10247, Birmingham, AL 35202 (referred to below as "Lender").

GRANT OF MORTGAGE.
