

**CERTIFICATE OF INCORPORATION  
OF

The undersigned Trustees of the above named Church hereby certify that the members of the Mountainview Church of Christ, did on the 28<sup>th</sup> day of May, 2000, duly assemble and duly adopt a resolution signifying their intention of forming this corporation for the purpose hereinafter set forth in accordance with the provisions of Sec. 10-4-20, Code of Alabama, 1975, as amended. The undersigned Trustees do also hereby certify that the members of the said Church on the 28<sup>th</sup> day of May, 2000, duly assemble and elect the undersigned as Trustees, all as shown by said resolution. A copy of said resolution is hereto attached, marked Exhibit "A", and made a part hereof by reference thereto as though fully incorporated herein. The undersigned further certify as follows:

1. That the name chosen for said corporation is:  
**Mountainview Church of Christ**
2. The Trustees of said corporation shall be the duly appointed elders. A man shall become a Trustee upon his appointment as elder to the Mountainview church and shall continue as a Trustee until such time as he ceases to be an elder of the Mountainview church.

At anytime the number of elders falls below three, an additional Trustee or Trustees shall be elected from the men of the congregation in order to meet Alabama law requiring said corporation to have a minimum number of three trustees. Trustees thus appointed shall serve until additional elders are appointed and the requirement of three Trustees can be met by elders, or for a period of 3 years, until their successors are elected.

Trustees are to be empowered to act on behalf of said Church only upon consent of the congregation expressed by resolution provided however, all ecclesiastical decisions are reserved to the elders duly appointed by the members of said Church.





**BE IT FURTHER RESOLVED** by the members of said Mountainview Church of Christ, that the above named trustees shall file within thirty days from this date, in the Office of the Probate Judge of Shelby County, Alabama, the county in which the said corporation is to exercise its functions, a certificate stating the corporate name selected, the names of the Trustees, and the length of time for which they were elected.





Held on the 28<sup>th</sup> day of May, 2000





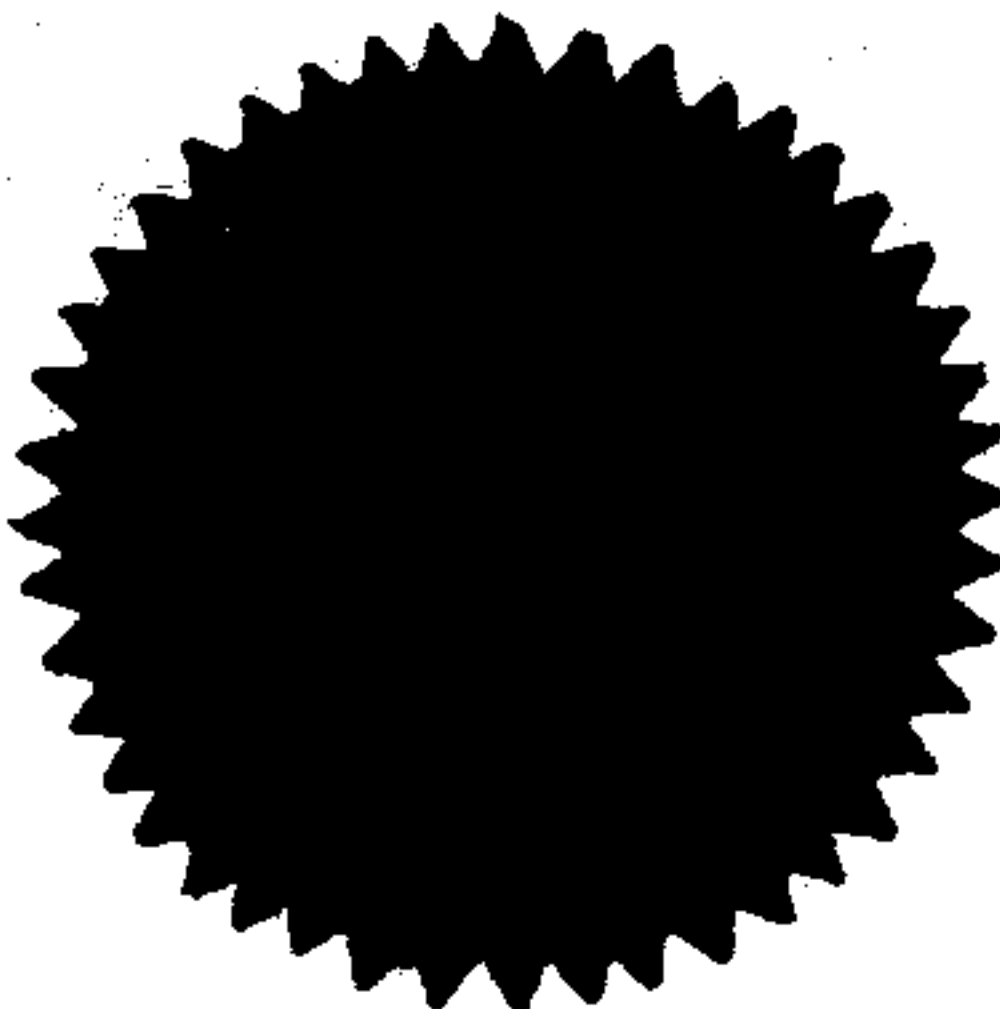
