**ORDER**

This matter coming before the Court on Plaintiff's Application, Affidavit and Entry of Default, the Court finds that the following judgment should be entered:

It is therefore ORDERED, ADJUDGED and DECREED as follows:

1. That a money judgment is hereby entered in favor of the Plaintiff, Building Materials Wholesale, Inc., and against the Defendant, Mayfield Homebuilders, L.L.C., and Defendant, M..D. Mayfield, in the amount of \$8,610.92, plus interest in the amount of \$1,389.08, for a total money judgment of \$10,000.00.

2. That a materialmen's lien in the amount of \$10,000.00, is hereby fixed and established in favor of the Plaintiff to the extent and ownership of all of the right, title and interest of Mayfield Homebuilders, L.L.C. in the following described real property located and situated in Madison County, Alabama, to-wit:

In accordance with the provisions of Section 35-11-226, Code of Alabama (1975), all papers and a certified transcript of this judgment are to be transferred to the Clerk of the Circuit Court for further proceedings in the Court regarding sale of the described properties and satisfaction of this judgment as provided by statute.
