THIS AGREEMENT of Modification made and entered into by and between Jayson Smitherman and April Smitherman, (hereinafter referred to as "Borrower") and First National Bank of Shelby County (hereinafter referred to as FNBSC), on this the 12th day of September, 2000.

WITNESSETH:

WHEREAS, Borrower, on the 30th day of August, 1999, executed to FNBSC a Note in the principal sum of \$81,000.00, ("Note"), which Note is secured by a mortgage conveying certain property situated in Shelby County, Alabama, which mortgage is recorded in the Probate Office of said County, Instrument Number 1999-36624 in said Probate Office, ("Mortgage"), reference being hereby made to the Mortgage for a particular description of the Note and the description of the property securing the payment of the Note (the "Mortgage Property") and

WHEREAS, there are no liens or encumbrances against the Mortgage Property, or judgments against the Borrower, and

WHEREAS, the amount due under the Note and Mortgage is \$81,000.00. As of this date, the sum of \$79,720.00 has been advanced out of total amount available.

WHEREAS, the Borrower has requested to increase said amount from \$81,000.00 to \$93,100.00, (an increase of \$12,100.00) and extend the maturity date of said loan to October 22, 2000 and

WHEREAS, Borrower is desirous of paying the balance of the Note and Mortgage in accordance with a loan plan of FNBSC, and the rules and regulations governing same;

NOW, THEREFORE, in consideration of the mutual benefits to flow to each of the parties hereto, the undersigned hereby agree and covenant as follows, viz:

- 1. The Borrower agrees to pay the Indebtedness secured by the Mortgage in the amount of \$93,100.00 in accordance with the following loan plan of FNBSC.
- (a) Interest shall accrue on the amount of the unpaid principal at the rate of 11.50% and shall be due on October 12, 2000 with the entire principal and any unpaid interest thereon shall be due and payable at maturity on the 2?nd day of October, 2000.
 - 2. The Mortgage will secure the advance as a valid first lien against the Mortgage Property.
