



4. The dissolution of said corporation was approved by written consent of all shareholders and a copy of the written consent of said shareholders is attached and incorporated herein as reference.





CONSENT OF SHAREHOLDER TO DISSOLUTION OF CORPORATION**


1. The undersigned, Anthony Jones, is a shareholder in Anthony Jones Builder, Inc., an Alabama corporation.
