MOOR, owner(s) as aforesaid of said real property and premises, and all the right, title, interest and claim of the NORTH SHELBY COUNTY LIBRARY DISTRICT on account of said charges in and to the following described real property situated in the County of Shelby, State of Alabama, hereinafter referred to, to-wit:

Commence at the NE Corner of said SW  $\frac{1}{4}$  of the SE  $\frac{1}{4}$  of Section 22, Township 18 South, Range 1 West, Shelby County, Alabama, and being more particularly described as follows: Commence at the NE corner of said SW  $\frac{1}{4}$  of SE  $\frac{1}{4}$  being the point of beginning; thence South 01 degrees 59 minutes 30 seconds East along the East line of said SW  $\frac{1}{4}$  of SE  $\frac{1}{4}$  for 100.0 feet to the beginning of a curve to the right, said curve having a central angle of 121 degrees 00 minutes 28 seconds, a radius of 66.00 feet and an arc length of 139.39 feet; thence proceed southwesterly along the arc of said curve 139.39 feet to the end of said curve and the beginning of a curve to the right, said curve having a central angle of 40 degrees 20 minutes 57 seconds, a radius of 71.00 feet and an arc length of 50.00 feet; thence proceed northwesterly along the arc of said curve for 50.00 feet to a point; thence South 65 degrees 03 minutes 36 seconds West for 20.95 feet to a point; thence South 01 degrees 59 minutes 30 seconds East and parallel with the East line of said SW  $\frac{1}{4}$  of the SE  $\frac{1}{4}$  for 479.42 feet to the beginning of a curve to the right, said curve having a central angle of 89 degrees 24 minutes 23 seconds, a radius of 125.00 feet, and an arc length of 195.06 feet; thence proceed southwesterly along the arc of said curve for 195.06 feet to the end of said curve; thence South 87 degrees 24 minutes 53 seconds West for 379.80 feet to a point; thence North 71 degrees 43 minutes 43 seconds West for 213.70 feet to a point; thence North 16 degrees 07 minutes 51 seconds East for 688.43 feet to a point on the North line of said SW  $\frac{1}{4}$  of SE  $\frac{1}{4}$ ; thence North 87 degrees 24 minutes 53 seconds East along the North line of said SW  $\frac{1}{4}$  of the SE  $\frac{1}{4}$  for the 639.85 feet to the point of beginning.

AND TO HOLD the same, the said rights, titles and interest unto the said NORTH SHELBY COUNTY LIBRARY DISTRICT and its heirs and assigns forever, but no right, title or interest of any reversioner or remainderman in said real property is conveyed hereby.
