SUBORDINATION AGREEMENT

This Agreement made this date by and between First Commercial Bank (herein called First Party), and McGowin & King Mortgage Company, LLC (herein called Second Party).

Whereas, First Party is the owner and holder of that certain mortgage recorded in Instrument No. 1998-20977 executed by Sue K. Selby and William E. Selby in the Probate Office of Shelby, Alabama, which mortgage encumbers the property described as follows:

The First Party, First Commercial Bank, consents and agrees that the lien of its mortgage recorded in Instrument No. 1998-20977 is and shall continue to be, subject and subordinate in lien to the lien of the mortgage being made to the Second Party, McGowin & King Mortgage Company, LLC, which mortgage in the amount of \$74,249.85 is recorded in Instrument No. 2001-00602 in the said Probate Office.
