ORDER

The defendant, Health Focus of Alabama, LLC, was served with the Summons and Complaint in this case on October 21, 2000; and said defendant has failed to file an answer or other affirmative pleading within the specified time period under the Birmingham Differential Case Management Plan.

On December 29, 2000, the plaintiff filed an Application, Affidavit and Entry of Default as to said defendant, Health Focus of Alabama, LLC; and on January 11, 2001, the plaintiff filed a Notice of Filing Affidavit of Carl Scott in connection therewith.

After due consideration thereof, DEFAULT JUDGMENT is hereby entered in favor of the plaintiff and against the defendant, HEALTH FOCUS OF ALABAMA, LLC, for the sum of FOUR HUNDRED FORTY EIGHT THOUSAND FOUR HUNDRED TWENTY-EIGHT AND 05/100 (\$414,428.05) DOLLARS, which is comprised of \$360,372.22 principal and interest and \$54,055.83 attorney's fees. Said judgment is entered without waiver of exemptions. Any costs in connection therewith are taxed to the defendant, Health Focus of Alabama, LLC.
