KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ONE AND NO/100 DOLLARS (\$1.00), AND THE PURPOSE OF CREATING SURVIVORSHIP TITLE, to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **AARON B. DOBIS, unmarried and SARA J. LITTY, unmarried**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **AARON B. DOBIS AND SARA J.
