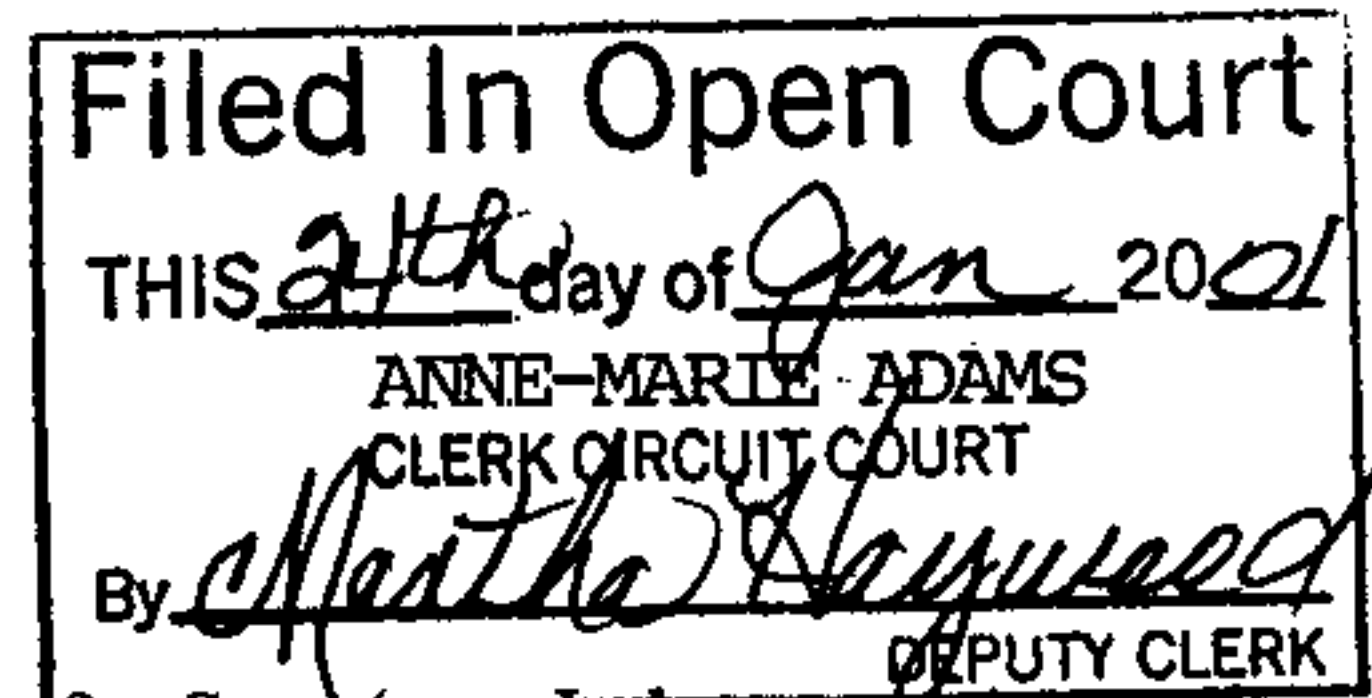

JUDGMENT



Before the Court is First Commercial Bank's Motion for Summary Judgment. Appearing at the hearing on the Motion on January 12, 2001 was Donald D. Knowlton for the Plaintiff, First Commercial Bank. The Defendants did not appear at the hearing and did not file a response to the Motion for Summary Judgment. The Court hereby finds based upon a review of the pleadings, and the Motion for Summary Judgment, and after having fully considered all matters contained therein, it is hereby ORDERED, ADJUDGED AND DECREED that First Commercial Bank's Motion for Summary Judgment is well founded and due to be GRANTED .

The Court hereby orders that the Plaintiff be awarded a final judgment in favor of First Commercial Bank and against the Defendants, Wallace D. Sears, Pachyderm Press, Inc. and Linda Sears for the following amounts:

Under Count One of the Complaint a final judgment is hereby entered in favor of First Commercial Bank and against Wallace D. Sears for \$28,380.23, said sum includes principal, interest and reasonable attorneys' fees.

Under Count Two of the Complaint a final judgment is awarded in favor of First Commercial Bank and against Wallace D. Sears for \$10,326.17, said sum includes principal and

reasonable attorneys' fees.

Under Count Three of the Complaint a final judgment is awarded in favor of First Commercial Bank and against Wallace D. Sears, individually, and Defendant, Pacyderm Press Inc., jointly and severally for \$4,525.17, said sum includes principal, interest and reasonable attorneys' fees.

Under Count Four of the Complaint a final judgment is awarded in favor of First Commercial Bank and against Wallace D. Sears, individually, and Defendant Linda Sears jointly and severally \$2,283.93, said sum includes principal, interest and reasonable attorneys' fees.

In summary, final judgment is awarded against Wallace D. Sears, in the total amount of \$45,515.50 under all Counts of the Complaint.

A final judgment is awarded in favor of First Commercial Bank and against Pacyderm Press Inc., in the amount of \$4,525.17 jointly and severally with Wallace D. Sears.

A final judgment is awarded in favor of First Commercial Bank and against Linda W. Sears, in the amount of \$2,283.93 jointly and severally with Wallace D. Sears.

There being no just reason for delay, the judgment is entered as a final judgment pursuant to Alabama Rule of Civil Procedure 54(b).

Costs are to be taxed to the Defendants.
