ORDER AND DECREE OF CONDEMNATION

THIS CAUSE was commenced on April 13, 2000, in the Probate of Shelby County, Alabama, by filing an application to condemn the property hereinafter described under and pursuant to Section 23 of the Constitution of Alabama, Title 18, Chapter 1, and Title 23-3-5 of the Code of Alabama, 1975. The parties, by and through their attorneys of record, have advised the Court that an agreement has been reached in this matter and the parties stipulate as follows:

- 1. All demands for jury trial are withdrawn with the consent of all parties.
- 2. An Order of Condemnation may be entered in the Circuit Court of Shelby County, Alabama, in this cause, granting the application for order to condemn the property therein described as prayed in said application and fixing the just compensation in the sum of \$133,000.00.
- 3. All costs to date shall be taxed against the Defendant, Greg Beers.
- 4. That the parties having a right, title, and interest in and to said property are: Greg Beers, Compass Bank and Annette D. Skinner, Tax Collector.

It is therefore, CONSIDERED, ADJUDGED, and DECREED by the Court that, pursuant to the stipulation of the parties, the damages and just compensation to which the Defendants in this cause is the sum of One Hundred Thirty-three Thousand and no/100 (\$133,00.00) Dollars. The Clerk of the Court is hereby authorized and directed to pay to the Defendants as their interest may appear, the sum of One Hundred Thousand and no/100 (\$133,000.00)

The Plaintiff, the State of Alabama, has heretofore deposited with the Judge of Probate, Shelby County, Alabama, the sum of One Hundred Twenty Thousand and no/100 (\$120,000.00) Dollars, which sum is currently in the possession of the Clerk of Probate Court. The Plaintiff, the State of Alabama, is hereby directed to pay to the Clerk of this Court the additional sum of Thirteen Thousand and no/100 (\$13,000.00) Dollars which, together with the sum previously paid to the Clerk of One Hundred Twenty Thousand and no/100 (\$120,000.00) Dollars, is the amount of just compensation due the Defendants of One Hundred Thirty Three Thousand and no/100 (\$133,000.00) Dollars.

It is hereby ORDERED, ADJUDGED and DECREED by the Court that the Clerk of this Court, upon receipt of the aforesaid sum of Thirteen Thousand and no/100 (\$13,000.00)Dollars, to be paid by Plaintiff, is hereby authorized and directed to pay the Defendants the sum of One Hundred Thirty-three Thousand and no/100 (\$133,000.00) Dollars which is the amount of just compensation due the Plaintiffs in this cause.

It is hereby ORDERED, ADJUDGED and DECREED by the Court that interest accrued on the funds invested in this case, be paid to the Plaintiff.

It is hereby ORDERED, ADJUDGED and DECREED by the Court that the Plaintiff, the State of Alabama, be and is hereby given and awarded and there is hereby transferred and conveyed to the Plaintiff, the State of Alabama, all interest in and to the following described land for the use and purposes sought in the application for Order of Condemnation. The said lands being condemned and awarded to the Plaintiff, the State of Alabama, are described as follows:
