TERMINATION OF TENANCY IN COMMON OPERATING AGREEMENT

WHEREAS, as a consequence of such transaction, the entire fee simple interest is now owned by Wal-Mart and, as a result of the full 100% conveyance of title, the Parties intend to terminate the Tenancy-in-Common Operating Agreement.

NOW, THEREFORE, in consideration of the premises, and the purchase by Wal-Mart of the undivided one hundred percent (100%) interest in the Property from Butch, Corley, Benner, McGeever and Robertson, the Parties agree that:

- 1. The Parties hereby waive their first right of refusal, granted under Paragraphs 2 (A) and 7 of the Agreement, to purchase the property in the event any party desires to sell;
- 2. Pursuant to Paragraph 9 (a) of the Agreement, the Agreement is hereby terminated effective as of April <u>13</u>, 2001, and none of the parties shall have any further obligation or liability to the other from and after April <u>13</u>, 2001 (the "Effective Date"), except for those provisions of the Agreement addressing indemnity of the Parties shall survive the Termination of the Agreement, including, but not limited to Paragraph 5(b), with respect to any occurrence prior to the Effective Date.
