

**ARTICLES OF INCORPORATION
OF

To the Honorable Patricia Yeager Fuhrmeister, Judge of Probate
of Shelby County, Alabama:

We the undersigned, desiring to become a body corporate, do hereby file the following Articles of Incorporation, pursuant to the laws of the State of Alabama, and the undersigned Incorporators do hereby make and subscribe their names to these Articles.

ARTICLE 1: NAME

The name of the corporation shall be **American Landmark Realty, Inc.**

ARTICLE 2: OBJECTS

The corporation has been organized for the following purposes: for the marketing and selling of residential and commercial real property, the purchase of related real estate, and the transaction of any or all lawful business for which corporations may be incorporated under this chapter. The corporation is a corporation organized for profit and shall be perpetual in duration.

ARTICLE 3: PRINCIPAL OFFICE AND REGISTERED AGENT

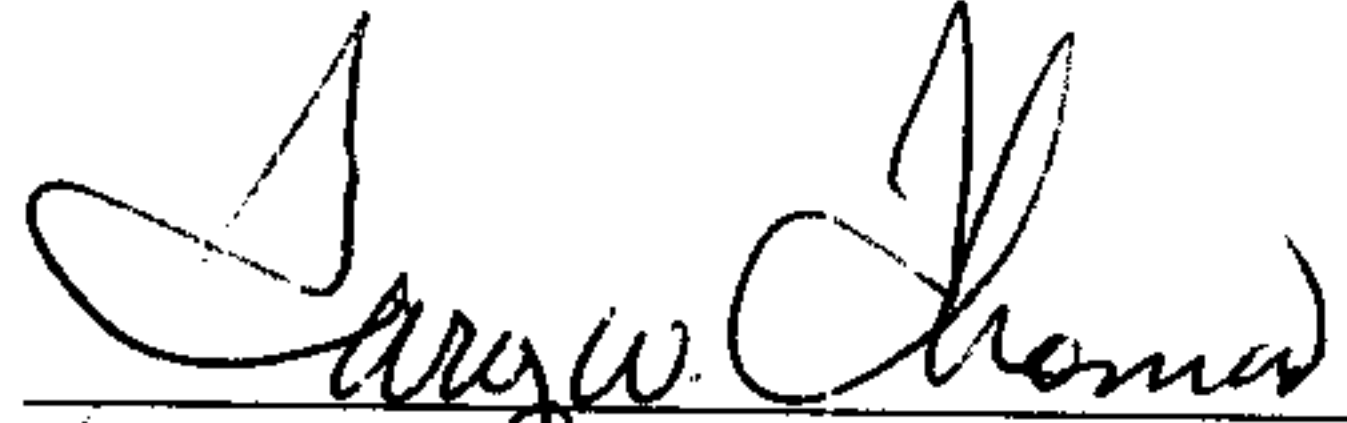
- a) To lend money and take security therefor, or to borrow money and give security therefor, on such terms as to the Board of Directors may deem proper and available.

- c) To engage in business as natural persons may, not inconsistent with the provisions of law pertaining to corporations in the State of Alabama.

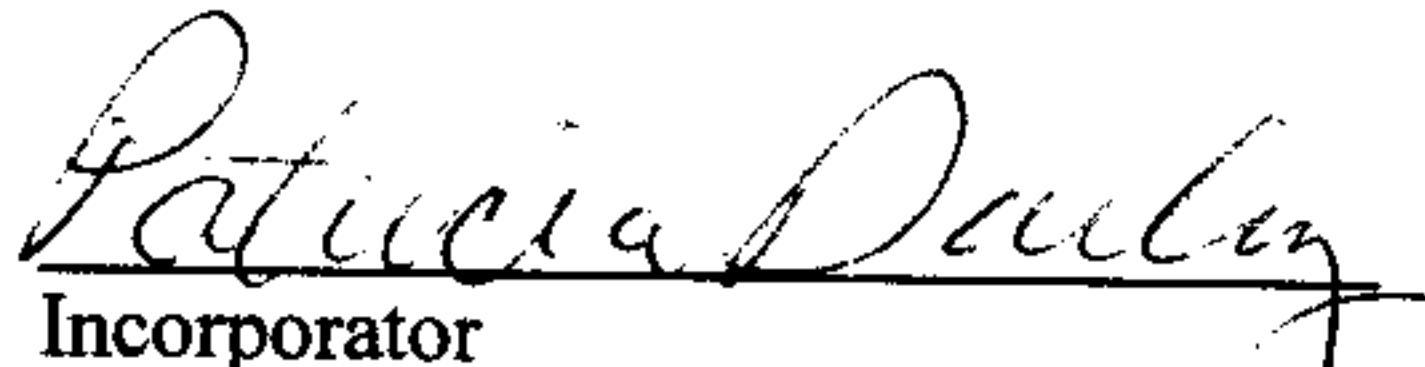
ARTICLE 7: RESTRICTIONS

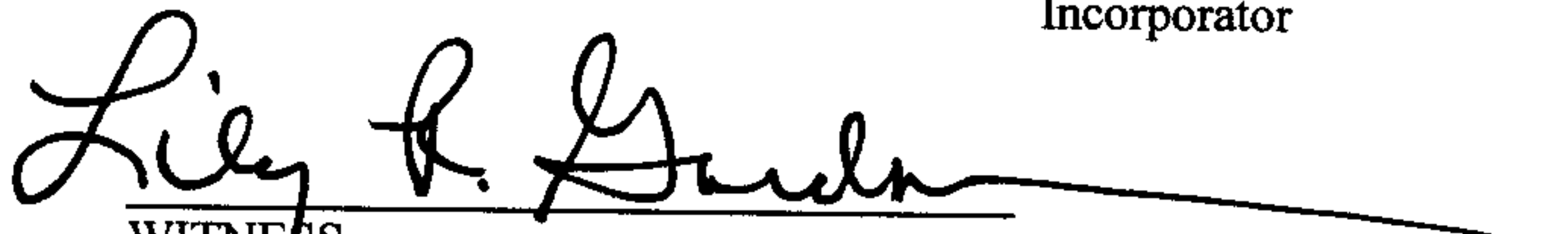
