KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Twenty-Five Thousand and No/100 Dollars (\$125,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **GARDNER BUILDERS, INC.** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **MICHAEL J. McDONALD and LAURIE SHERLENE McDONALD**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in SHELBY County, Alabama, to wit:

Lot 128, according to a Survey of Camden Cove, Sector 2, as recorded in Map Book 27, Page 26, in the Office of the Judge of Probate of Shelby County, Alabama.
