KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Six Hundred Seventy-One Thousand Three Hundred and 00/100 (\$671,300.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **James Woods Development, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Milton G. Silva-Craig, and wife, Stephanie K. Silva**, (hereinafter referred to as GRANTEE), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

\$469,900.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.




James Woods Development, Inc. was formally known as Paragon Properties, Inc.
