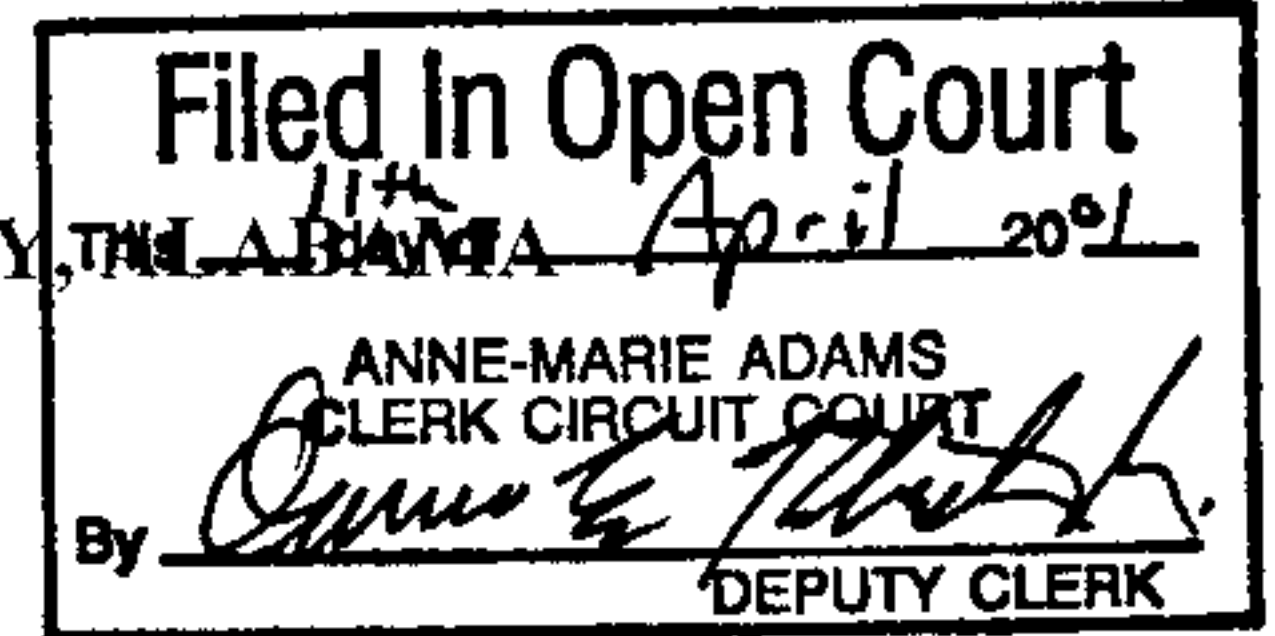

WHEREAS, Comtron, Allegiance and One E-Vantage have agreed to entry of a Consent Judgment in settlement of this case.

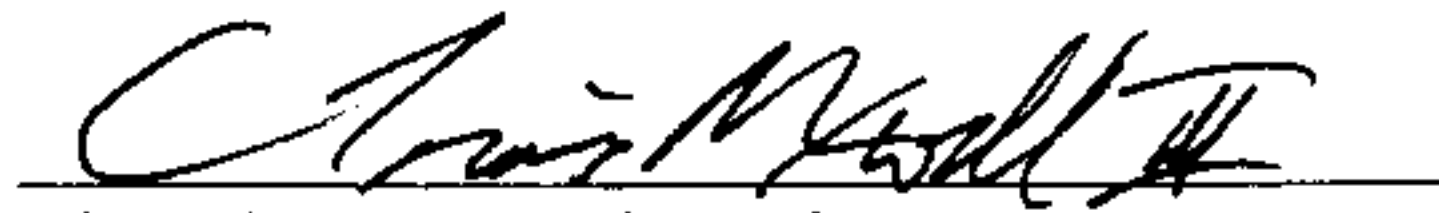
