

ARTICLES OF ORGANIZATION OF MR. CASH GEORGIA LLC, LIMITED LIABILITY COMPANY/LLC

Pursuant to the Provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

The name of the limited liability company is MR. CASH GEORGIA LLC, Limited Liability Company/LLC. (The "Company").

ARTICLE II

Duration

The Company shall have a perpetual duration from the date of organization in perpetuity unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act").

- (a) Provide fee based check cashing operation and incentive based Internet service and to buy, lease and sale small electronic equipment and household items;
