KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Thirty Thousand Seven Hundred Twenty-Five and No/100 Dollars (\$130,725.00) the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **OLD SOUTH BUILDERS, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **RANDALL EUGENE MITCHELL & BETH JOYCE MITCHELL**, herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 205, according to the Resurvey of Final Plat, Stagecoach Trace, Sector 2, as recorded in Map Book 28, page 105, in the Probate Office of Shelby County, Alabama.
