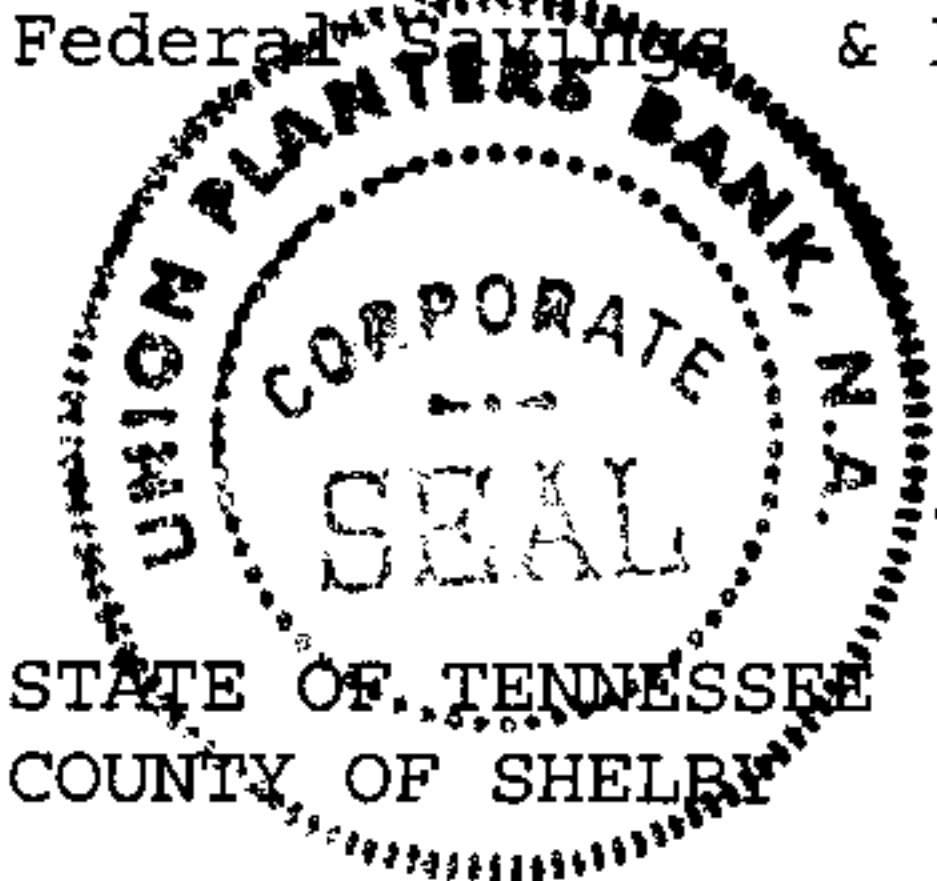
Whereas, on the 1 day of May 1978.

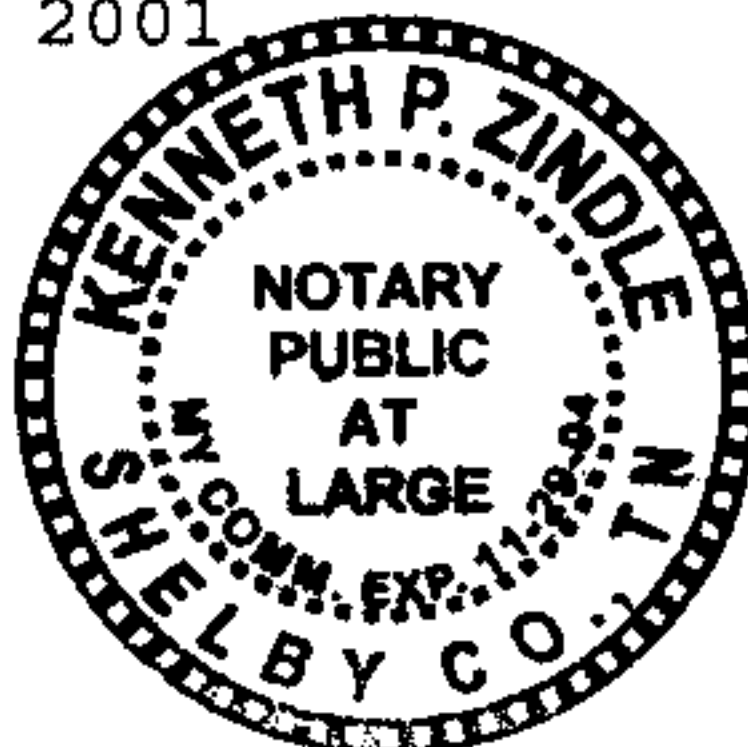
