I hereby nominate, constitute and appoint my wife, Aleen P. Schrader, as sole Executrix of this my IAST WILL AND TESTAMENT, and I exempt her from giving any bond or security to qualify to act as such Executrix. I do further exempt her from making any inventory or report of final settlement of the administration of my estate to any court whatsoever. I fully authorize and empower my said Executrix to do all things necessary for the complete administration of my estate, to compromise, adjust and otherwise settle all claims, debts, charges or demands against or in favor of my estate as fully as I could do if living.

In the event my wife, Aleen P. Schrader, should predecease me, or death
