1. The name of the corporation is Key Plumbing & Heating Company, Inc.
2. The period of duration is perpetual.
3. The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which the corporation may be incorporated under the Alabama Business Corporation Act.
4. The aggregate number of shares of capital stock which the corporation shall have authority to issue is 1,000 shares of common stock.

6. The number of directors constituting the initial board of directors of the corporation is one and the name and address of the person who is to serve as the director until the first annual meeting of the shareholders until the successors are elected and shall qualify are as follows:


7. The name and address of the incorporator of the corporation is Horace L. Key. His address is P. O. Box 1046 Pelham, AL 35124.
