WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Three Hundred Fourteen Thousand Five Hundred and 00/100 Dollars (\$314,500.00), in hand paid to the undersigned, Michael Wayne Lewis and wife, Dora McCarty Lewis, (hereinafter referred to as the "Grantor") by Charles A. Shaw and wife, Kimberly P. Shaw, (hereinafter referred to as the "Grantee"), as joint tenants with the right of survivorship, the receipt and sufficiency of which is hereby acknowledged, the Grantor does, by these presents, grant, bargain, sell, and convey unto the Grantee the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 3304, according to the Survey of Riverchase Country Club 33rd Addition, as recorded in Map Book 16, Page 112, in the Probate Office of SHELBY County, ALABAMA.

SUBJECT TO:

- 1. Ad valorem taxes due and payable October 1, 2002.
- All restrictions, easements, Rights of parties in possession, encroachments, liens for services, labor, or materials, taxes or special assessments, building lines.
- Easements, Encroachments, rights of ways, building set back lines, as shown on recorded plat.

TO HAVE AND TO HOLD unto the Grantees, as joint tenants with the right of survivorship, their heirs, executors, administrators and assigns forever.

The Grantors does for itself, their heirs, executors, administrators and assigns, covenant with the said Grantees, their heirs, executors, administrators and assigns, that it is lawfully seized in fee simple of said premises; that the premises are free from all encumbrances except as noted above; that it has a good right to sell and convey the same as aforesaid; and that it will, and their heirs, executors, administrators and assigns shall, warrant and defend the same to the said Grantees, their heirs, executors, administrators and assigns forever, against the lawful claims of all persons.
