KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Sixty-Nine Thousand Nine Hundred and 00/100 (\$169,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Keystone Building Co., Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **David J. Humphrey and Pepi N. Humphrey, husband and wife**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Lot 9, according to the Survey of Pecan Grove, as recorded in Map Book 28, Page 11 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Keystone Building Co., Inc. and Keystone Building Company, Inc. are one and the same entity.

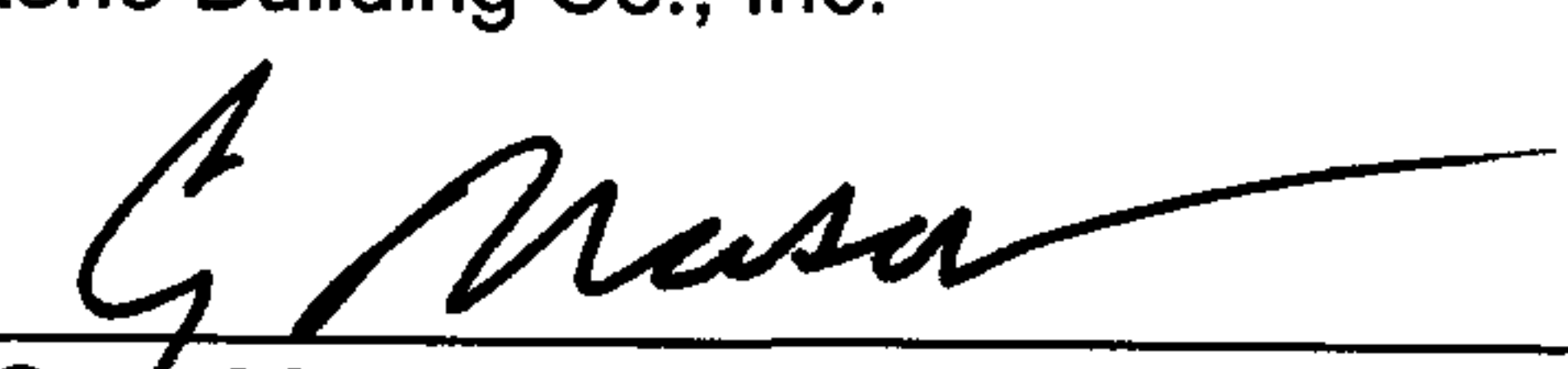
Judy Williamson and Judy H. Williamson are one and the same person.

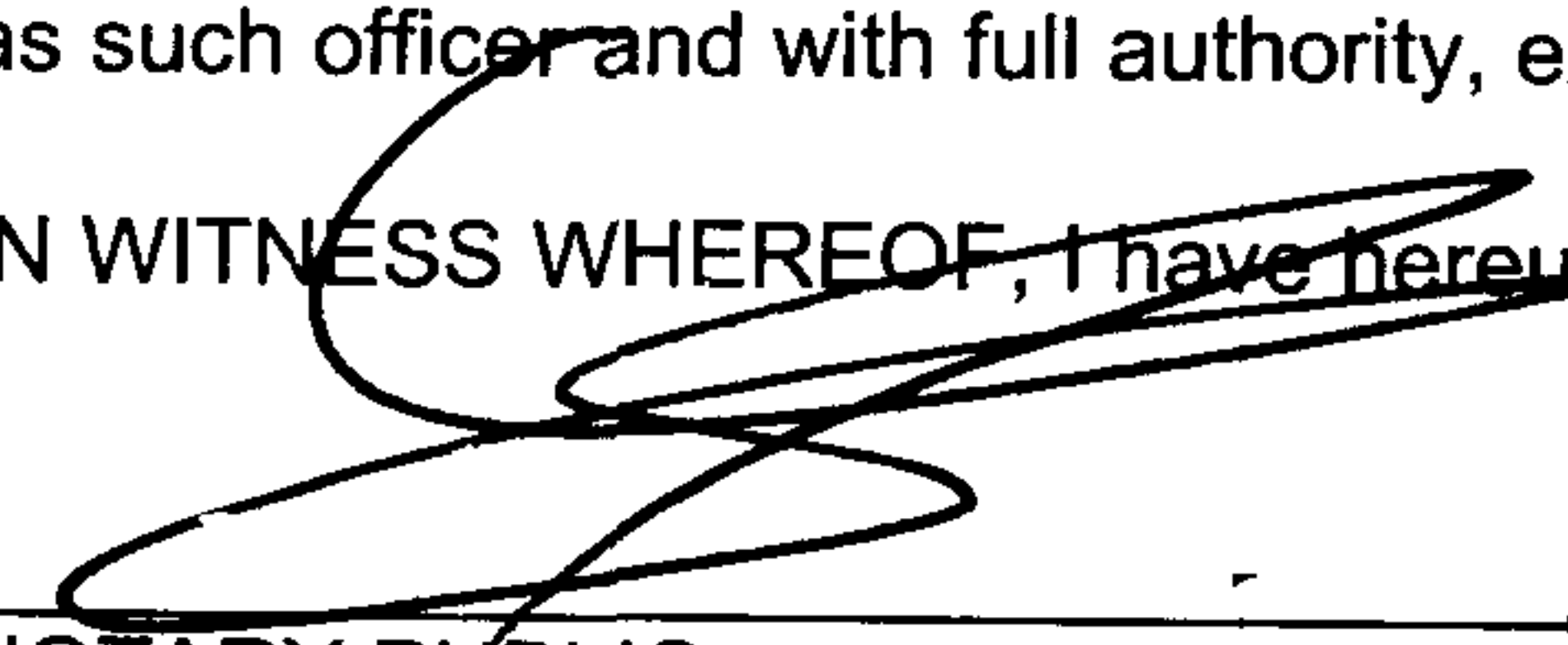
