KNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a Durable Power of Attorney, that I H. Arrant of Shelby County, State of Alabama, as my true and lawful Attorney-in-fact, for me and in my name, place and stead, and on my behalf and for my use and benefit, to do, perform and execute all and every act that I may legally do through an attorney-in-fact, and every proper power necessary to carry out the purposes for which this power is granted, with full power of substitution and revocation, hereby ratifying and affirming that which the said Donnie P. Arrant or his substitute shall lawfully do or cause to be done by himself or his substitute lawfully designated by virtue of the power herein conferred upon him.
