

ARTICLES OF ORGANIZATION OF
MAGIC CITY PRINTING SERVICES, LIMITED LIABILITY COMPANY

I, THE UNDERSIGNED NATURAL PERSON OF AGE, NINE TEEN YEARS OLD OR MORE, ACTING AS ORGANIZER OF A LIMITED LIABILITY COMPANY ACT OF THE STATE OF ALABAMA, HEREBY ADOPT THE FOLLOWING ARTICLES OF ORGANIZATION FOR THE LIMITED LIABILITY COMPANY:

ARTICLE ONE

ARTICLE TWO


ARTICLE TEN


