

A part of the NE 1/4 of the NE 1/4 of Section 26, Township 21 South Range 1 West, Columbiana, Shelby Coutny, Alabama, more particularly described as follows:

Beginning at a point where the East Line of North Main Street in Columbiana intersects the North line of Meyer Street (a former alley according to Horseley's Map) and run thence Northerly alon g the said Eadst line of said North Main Street a distance of 80.0 feet to an existing steel plin corner; thence turn 91 degrees 06 minutes 21 seconds to the right and run Easterly parallel with the North line of said Myer street a distance of 251.31 feet to a steel pin in the centerline of an open drainage ditch; thence turn 125 degrees 42 minutes 56 seconds to the right and run Southwestely along said centerline of said ditch a distance of 98.05 feet to a steel pin set on the North line of same said Myer Street; thence turn 54 degrees 10 minutes 20 seconds to the right and run Westerly along said North line of said Meyer Street a distance of 192.53 feet to a steel pin and the point of beginning.
